I welcome diversity in all its forms and recognise the benefit of collaboration to secure the means by which solutions can be found to the wicked problems and systemic barriers in delivering end to end trust.

Mydex is a community interest company founded 16 years ago in Scotland. We are an SME and believe we can contribute some unique perspectives to the OIX Board to ensure a diversity of perspectives and be an able representative of OIX members of all persuasions.

Mydex CIC has designed and built, using open source software and specification a series of digital trust platforms delivering Identity As a Service, Personal Data Exchange, Personal Data Stores and Master Reference Data Services that underpin the digital economy across all sectors. These platforms are all API based using open standards for interoperability with anyone stakeholder.

To enable trust and the end to end as a means of enablement we provide a series of People and Subscriber Web applications that enable a human rights based approach to delivering seamless integrated services that connect People (the community we serve) and our subscribers drawn from the public, third and private sector.

Our subscribers pay us low cost subscription fees and our Members (People) have free use of our platforms and services in perpetuity with no trade offs in terms of the privacy, control, agency and their ability to assign guardianship to secure support from friends and family and undertake guardianship for other People. Our platforms are built with People at the centre with privacy by design as a core foundation of our architecture and approach.

We have been a fully independently certified company under ISO27001 Information Security Management Systems and FairData Certification for over 10 years. This is core to our mission and the demonstrable trust that comes from independent scrutiny and transparency.

We have been involved in identity programmes in the UK for most of those years including the Identity Assurance Programme and GOV.UK Verify.

We are an active contributor to the UK Digital Identity and Attributes Trust Framework and the UK National Data Strategy and the Data Intermediaries Working Group. We sit on the industry partners certification working group for Holder Services (personal data stores and wallets). We are an associate member of the Open Wallet Foundation and a Member of the OpenID Foundation.

We have been a Member of OIX for over 10 years and an active member and contributor to the OIX programme through participation in working group's covering GAIN, Trust Frameworks and Wallets. I personally invest considerable time in that participation, actively preparing for working groups and giving a potentially unique perspective serving our community of People we call our Members.

I bring our extensive practical experience of person centred architecture and design that at its foundations takes a human rights based approach that is being embraced by our subscribers who seek to remove the friction, effort, risk and cost experienced by People and the front line teams who work in our subscribers (relying parties).

We invest extensively in interoperability and have been delighted with work on OIX to deliver a world leading analysis of Identity with the latest deliverable being the DNA of Identity Report and the development of OCET. We have participated in a number of OIX projects including shared signals, identity assurance and the development of the Good Practice Guides GPG 44 and 45.

We are a founding members of MyData Global a movement focusing the empowerment of individuals to independently hold their own personal data and share it when and where they need to safely, securely, share their verified personal data with trusted with our subscribers as part of normal operational service delivery and onboarding as well as contributing into a wide range of research and data spaces designed to drive wider insight and security of the digital economy and public services.

We are on the Board of tScheme who we have been a member of for over 10 years since the selection of tScheme as the underlying independent approvals for GOV.UK using detailed profiles to drive independent assessments by UKAS approved assessors.

I also sit on the Fair Data Certification Board that is committed to the practical implementation and audit of organisations GDPR compliance against 12 core principles in how they use personal data.

Mydex CIC is an FCA approved Account Information Service provider under Open Banking and sit on the JROC Expert Advisory Group reviewing and addressing the recommendations of the JROC report which seeks significant improvements in Open Banking, its interoperability, adoption and the trust and confidence the general public and the different actors involved need to ensure trust and protection is enabled end to end.

Mydex CIC publishes it's own white papers exploring the surprising economics of personal data that is hidden in plain sight which is transformative for the Digital Economy and Society and unlock the true potential for the benefit of all stakeholders.

Our core economic model is one of cost out, through efficieny, and improvements in outcomes and experience for our Members (People) and our subscribers and a range of application vendors and service providers who provide our subscribers with their back office systems. Our platforms could be seen as the People's platforms giving them a trusted digital presence across any sector and services within them.

To deliver practical usable online Open Criteria Exchange Tool (OCET) that all can subscribe to and make use of and help maintain. I would propose that this is a free service to members and scheme operators and enable self management of mappings for each scheme operator and standards provider. I believe it will be possible to secure funding to operate such a service and operate at a low cost, in a resilient, constantly available basis.

To continue to proactively engage with other national and sector identity and attribute ecosystems to bring them to OIX membership and support. To be seen as neutral, trusted enabler of dialogue and interoperability anywhere across the Globe.

To join the dots between other policies and programmes that will benefit from the Attributes ecosystem to promote attribute service provision in digitally portable in a machine readable format to drive interoperability.

These policies and programmes need to connect data controllers into the Attribute Service Provision directly to support independent portability to other service providers and People equipped with means of receiving, collecting, storing of attributes about the activity surrounding their life and interactions with data controllers by exercising the GDPR rights including the direct sharing with relying parties and other service providers and other People

To support the drive for growth of OIX through recruitment of new members and specifically attracting relying parties of all sizes large and small, local and international who deliver services to People. To demonstrate the value of OIX membership as a secure and trustworthy route to insight and engagement a practical investment in accelerating their own adoption of digital and identity and verified attribute exchange that can streamline their end to end service journeys across their own network and value chain of partners.

To promote independent certification that reinforces trust and confidence in the digital economy and the portability and interoperability across schemes, regions, countries globally.

To promote the power of a human rights based approach that equips people with independent tools available within markets using different economic models that can be layered to meet different Peoples requirements and provide OIX members with demonstrable economic models that deliver value back to their own organisations.
